- Mayor Jakubiak called the meeting to order at 6:33 p.m. Those present were Sheila Maki, George 1 Brauneis, Tom Wills and Gerald Pearson. Wendell Koontz and West McKee were not present.
- Those present recited the Pledge of Allegiance. 2.
- Tom Wills moved to approve the minutes for September 10, 2009 with the following corrections; 3. Paragraph # 5, line 4 should state, frontage not access, and paragraph 4, Greg is spelled with one "g", seconded by Gerald Pearson, with all in favor.
- 4. Liquor License Renewal The Trustees reviewed the Liquor License Renewal for City Market. Sheila Maki moved to approve the renewal, seconded by George Brauneis, with all in favor.
- Opening and Consideration of Reroofing Bids 5. Mayor Jakubiak opened the sealed bids for the reroofing of the Town Hall building. The Trustees asked Mike Owens to review the five bids received and bring the consolidated information to the Trustees.

Gerald Pearson moved to donate \$ 75.00 to the Hotchkiss FFA for the 2009 Halloween Party, seconded by Sheila Maki, with all in favor.

7. Water Plant Project Update

Engineer Fagan asked if there were questions on her written report. There were none. Mike Owens stated the work at the plant is moving along well.

Enhancement Project Update 8.

Engineer Fagan reported CDOT is not easily approving the safety crossing light the Trustees wanted on HWY 133. CDOT would like a simple Yield sign on the highway. The Trustees asked the engineer to continue working with CDOT concerning the safety light. Engineer Fagan stated she will talk to CDOT and see if the project can go to bid and work on the light issues during construction. The trail through the school will be completed first and the ADA stairs on the hill up to Main Street will be completed in spring of 2010.

- Five Minute Public Appearance 9. Clerk Searle showed the Trustees an aerial picture of the Town taken in July of 2008. Tom Wills moved to purchase a 20X30 framed picture, seconded by Sheila Maki. George Brauneis voted against the motion. The motion passed.
- 10. Hotchkiss Planning Commission Update Tom Wills reported the commission reviewed the Master Plan and looked at the "to do list". The community survey showed the need and want for walk ability within the Town. The Planning Commission will look at the sidewalk ordinance the Town now has and work on a 10 to 20 year plan for improvement of sidewalks within Town. Tom would like to review the IGA with the County at the November Trustee meeting.
