- 1. Pro Tem Sheila Maki called the meeting to order at 6:30 p.m. Those present were Wendell Koontz, George Brauneis, Tom Wills and Gerald Pearson. Mayor Jakubiak was not present.
- 2. The present recited the Pledge of Allegiance.
- 3. Wendell Koontz moved to approve the minutes for February 11, 2010 with the following change; paragraph # 7 "Delta" in front of County Master Plan, seconded by Gerald Pearson, with all in favor.
- 4. Marshal Miller presented an award of merit of valor and a letter of accommodation to Deputy Featheringill for rescuing a citizen from a burning home.

## 5. Public Hearing

Dan Bolton requested permission to keep livestock in Town at 555 Cedar Street. He would like to have cows and calves on the property. There were no comments for or against.

Mr. Bolton was reminded to present his request to the Town Trustees before the cows are on the property.

## 12. Resolution 2010-2

## 16. Water Plant Update

Engineer Fagan said the plant is coming along and the inside of the plant is almost complete. Electric will be installed next week. The current plant is doing fine. Water storage is good.

## 17. Enhancement Project Update

Engineer Fagan reported CDOT had ruled that Extreme Construction has completed all the bid documents in a good faith effort and has approved them as the low bidder on the project.

Wendell Koontz moved to concur with CDOT and award the contract for the middle school trail to Extreme Construction, seconded by Tom Wills, with all in favor.

Engineer Fagan will notify them and have them get all insurance and bonding to her and set a pre construction meeting.

Engineer Fagan reported to the Trustees that another enhancement grant is available and the deadline to apply is April 1, 2010. The monies would be available in 2011, 2012 and 2013. The Trustees asked the Engineer to apply for the funds and see what happens.

The Trustees reviewed the letter from CDOT for the triggers for a pedestrian light on HWY 133. The Trustees asked that the letter be kept on file and crossing counts be recorded periodically.

Engineer Fagan asked if Structural Engineer Dean Bosworth could be an employee for the Town during the construction of the second phase of the trails on the Orlando property south of Town.

Wendell Koontz moved to approve the temporary employment of Dean Bosworth for the Orlando Trail, seconded by Tom Wills, with all in favor.

Engineer Fagan reported the health department will not take the Town off the funding list for the high school water line improvement if the environmental study is completed, and that the Town be ready to proceed with the project if stimulus grant money becomes available.

Tom Wills moved to approve the completion of the environmental study for the high school line with a dollar limit of \$2,000, seconded by Wendell Koontz, with all in favor.

## 19. Hotchkiss Planning Commission

Tom Wills reported they discussed the marijuana regulations and suggested the following; 500 feet from a school, playground, or daycare center, be located in the commercial zone, and that it be a use by review. Some of the other comments/concerns are security of building, background checks, and mobile units, license them on the same order as liquor license applications. Attorney Briscoe will work on regulations/ordinances and get them to the Trustees.

Tom Wills also reported they are working on plans for the sidewalks and trails in Town.

#### 21. Department Report

Mike Owens asked if there were questions on his report. Mike reported the street sweeper is repaired and being used. The County Fair Grounds water line is close to completion. They will be working on the gas, electric, and sewer lines.

Attorney Briscoe said he has been working with the County to reestablish the street frontage for the Cooley property on 5<sup>th</sup> Street. Nicewicz will be doing the surveying of the area and the County will share in the cost of the survey.

Marshal Miller asked if there were questions on his written report.

Dan told the Trustees there will be a big concert at the Fair Grounds on July 6<sup>th</sup>.

Wendell Koontz asked if the replaced bullet proof vests could be used, Marshal Miller said only for target practice.
