- 1. Mayor Koontz called the meeting to order at 6:30 p.m. Those present were Sheila Maki, Marlin McCracken, Dustyn Foster, Lindee Cantrell, Jane Wills, and George Brauneis.
- 2. Those present recited the Pledge of Allegiance.
- 3. Sheila Maki moved to approve the minutes for November 4, 2010 with the following corrections; paragraph # 6 2012 to 2011, # 15 fells to feels, # 23 Chambers to Chamber and # 24 Commission to Commissioner, seconded by Dustyn Foster, with all in favor.
- 4. Public Hearing Community Input on Medical Marijuana Centers/Growing Operations

Mayor Koontz addressed the public stating the State of Colorado voters approved medical marijuana centers and this hearing is for public input on rather to allow, with regulations, or ban centers/operations within the Town limits. A sign in sheet was provided for those that wish to address the Trustees. The comments will be held to two minutes per speaker and Mayor Koontz asked speakers not to repeat an earlier comment. The Trustees are holding this public hearing to hear comments and concerns, not to debate or comment. Thirteen citizens spoke, of those, seven were against centers/operations, (six were in Town residents), and six were in favor, (all six were from out-of-Town limits).

Mayor Koontz thanked the citizens and told them the Trustees will have a work session on January 13, 2011, prior to the regular meeting to discuss the comments/information they have received. Mayor Koontz reminded everyone they can send written or e-mail comments until the January meeting.

5. Rich Bailey, Sheep Dog Trials

Rich Bailey reported this is the 8th year for the dog trials and it gets bigger each year. He thanked the Trustees for their support and is requesting a donation for 2011. The donation goes toward awards. The trials will be held Mother's Day weekend May 5, 6, and 7, 2011.

Marlin McCracken moved to do a commercial sponsorship for \$ 500 for 2011, George Brauneis asked if the Town could donate more money in 2011. Mayor Koontz reminded the Trustees that money is being transferred from reserves to balance the General Fund in 2011, Sheila Maki seconded the \$ 500 sponsorship, with all in favor.

6. North Fork Ambulance Association

Sheila Maki read a letter from the NFAA Board reporting they have approved 17 new volunteers in the North Fork, seven from the Hotchkiss area. They thanked the Town and community for their support.

7. Liquor License Renewal

The Trustees reviewed the renewal for the Past Times Tavern. Marshal Miller reported there have been no problems.

Sheila Maki moved to approve the renewal, seconded by Lindee Cantrell, with all in favor.

8. Water Loan Payoff

The Clerk requested the pay off the loan with Berkadia for the water plant that originated in 1979. The cost of the pay off is about \$ 238,000. The loan pay off is scheduled for 2017.

George Brauneis moved to pay the loan off in 2010, seconded by Sheila Maki, with all in favor.

9. 2011 Budget

Sheila Maki moved to adopt Ordinance 2010-6 to adopt the 2011 Budget, seconded by George Brauneis, with all in favor.

Trustee Lindee Cantrell had to leave the meeting at this time.

Sheila Maki moved to adopt Ordinance 2010-7 to adopt the 2011 Mill Levy, seconded by Dustyn Foster, with all in favor.

Sheila Maki moved to adopt Ordinance 2010-8 to Appropriate Sums for 2011 as an emergency, seconded by Marlin McCracken, with all in favor.

10. Building Inspector Update

Mayor Koontz reported to the Trustees there were 11 applications for the contract position and interviews will be held on December 10th, with an inspector on board by January 1st.

11. SBA Cell Tower – Buy-Out Offer

Attorney Briscoe read the letter he sent to SBA with the counter offer from the Town. He read the response from SBA refusing the counter offer. The lease will remain as is and an extension on the lease will be discussed at a later date.

12. Leroux Creek Planning Update

There was not a meeting in November.

13. Medical Marijuana Discussion

Mayor Koontz said there will be a work session at 5:30 p.m. prior to the regular meeting on January 13, 2011 to discuss information received.

14. High School Water Line Project

Engineer Fagan told the Trustees the plans are almost complete and will be sent to the health department. They have 45 days to review. The wetlands evaluation is not complete yet. The bids for the project should be out early 2011 and presented to the Trustees in the February 2011 meeting.

15. Enhancement Project Update

Engineer Fagan reported that they met with CDOT and will be meeting with the railroad representatives next week. This trail will be more difficult to complete than the middle school trail.

The Trustees reviewed the letter to the railroad stating the Town will pay up to \$2,500 for their expenses. This money will not be reimbursed by the grant. Attorney Briscoe said the right-of-way title research will not be reimbursed by the CDOT grant either. The above items are being completed before the bid is awarded, so there is not a reimbursement for these expenses.

16. Five Minute Public Appearance

None.

17. Hotchkiss Planning Commission Update

There was not a meeting in November. There will not be one in December unless needed. The next meeting will be on January 27, 2011.

18. Department Reports

Mike Owens asked if there were questions on his written report. There were none. Mike reported they will be starting a replacement program for the clay tile sewer lines in Town.

The curb and gutter on the south side of Orchard between 2nd and 3rd should be complete by next week. Pall is working with the Town on lowering the TOC's on the effluent water at the plant.

Marshal Miller asked if there were questions on his written report. There were none. Sheila Maki stated the Creamery Arts Center is having Santa this weekend and the Town's Santa is next weekend, maybe next year they can be coordinated together. Mayor Koontz reminded the Trustees of the police ride along policy.

19. Hotchkiss Chamber of Commerce Update

Marshal Miller reported that the officers for the Chamber stayed the same. The Chamber members are looking at ways to better communicate with the businesses in Town.

20. Mayor's Report

Mayor Koontz suggested that the Trustees approve a \$150 to \$200 City Market gift card for staff and a \$50 gift card for the Trustees.

Sheila Maki moved to give the employees \$ 100 gift cards and the Trustees \$ 50; George Brauneis suggested \$ 200.00 for the employees, Sheila Maki amended her motion to \$ 200 for employee and \$ 50 for the Trustees, seconded by George Brauneis, with all in favor.

Clerk Searle thanked Leonard, Don and Greg for putting up the Christmas lights in Town and at the Town Hall building.
