- 2. Mayor Koontz welcomed the Hotchkiss High School State Champion Girls Cross Country Team.
- 3. Those present recited the Pledge of Allegiance.
- 4. Carrie Wingfield approved the minutes for October 11, 2012 with the following corrections; paragraph #5 Delta County Economic Development is the financial agent for North Fork Heart and Soul, and paragraph #8 Pass the Mic, seconded by Dustyn Foster, with all in favor.
- 5. Liquor License Renewal Past Times Tavern Marshal Miller said there were no problems. Carrie Wingfield moved to approve the liquor license renewal for the Past Times Tavern, seconded by Dustyn Foster, with all in favor.
- Donation Requests
 Bulldog Booster Club Anita Violett and Christy Hawk requested a donation to complete the concession stand at HHS and the picture wall at HHS.
 Carrie Wingfield moved to approve a \$500 donation to the Bulldog Booster Club, seconded by Georgia Hopper, with all in favor.

North Fork Children's Christmas Party James Roberts moved to donate \$500, seconded by Carrie Wingfield, with all in favor.

Hotchkiss Community Dinners Larry Jakubiak will be serving Thanksgiving and Christmas dinners at the Senior Citizen Site. Georgia Hopper moved to donate \$500, seconded by Carrie Wingfield, with all in favor.

- 7. Keeping of Livestock in Town
 Dan Bolton requested keeping of about 200 sheep at 480 Cedar Drive for 3 to 4 weeks. There
 will be a herder with them.
 Marlin McCracken moved to allow the keeping of the livestock in town for the 3 to 4 weeks,
 seconded by Carrie Wingfield, with all in favor.
- North Fork Ambulance Recruitment Sheila Maki told the Trustees that it is time for the annual NFAA's recruitment. Paonia and Crawford are in need of volunteers. Drivers and EMT's are needed. There is an EMT training class on January 6, 2013. Also, Hotchkiss is looking for a board member.
- 9. Ordinance 2012-2 Model Traffic Code Amendment The Model Traffic Code will be amended from 2003 to 2010 with this Ordinance and it will bring the Town into compliance. Attorney Nettleton completed the work on the amendment. Attorney Nettleton said there are certain parts pertaining to the Town of Hotchkiss. Carrie Wingfield moved to adopt Ordinance 2012-2, an Ordinance for the regulation of traffic by the Town of Hotchkiss, Colorado; Adopting by reference the 2010 edition of the Model Traffic Code repealing all Ordinances in conflict therewith; and providing penalties for violation thereof. Seconded by Dustyn Foster, with all in favor.
- Ordinance 2012-3 Amending the Zoning Code Parking
 This Ordinance will change the parking regulations for two blocks on either side of the core area
 of Town.

 Carrie Wingfield moved to adopt Ordinance 2012-3 amending the zoning code as to specific
 provisions regarding the C-2 MU Zone allowing new uses in specific areas within the zone

which may be established within existing structures to provide only one half of the off-street parking required by Appendix A of the zoning code, seconded by Georgia Hooper, with all in favor.

- North Fork 20/20 Meeting Dustyn Foster Dustyn told the Trustees there will be a meeting on November 15th.
- Sidewalk Ordinance The Planning Commission is still working on the ordinance. Attorney Briscoe asked Trustee to send him their concerns/questions.
- 13. Downtown Improvement Discussion Tom Wills said the Chamber of Commerce will give \$2000 to the project for planters and trees for the vacant bank owned property on Bridge Street. Planters with benches attached will be placed on Bridge Street. The Town has budgeted \$2300 for the project. Attorney Nettleton thanked the Downtown Improvement volunteers for the cleanup on the Turnbull alley.
- 14. Enhancement Trails Project Update Engineer Fagan gave the Trustees a written report on the projected cost and the CDOT/Town contribution. The Town could return the CDOT money and spend Town money and have the Public Works employees to the work and not have to jump through the CDOT regulations. The project would take a lot longer. Engineer Fagan recommended the use of CDOT money with Town match. The Safe Routes to School funding will be a 20% match from the Town and is not a lot of value to the Town at this time. The Trustees will make a final decision at the December meeting.
- Delta County Housing Task Force Georgia Hopper reported she attended the last meeting and visited the Delta Villa housing units. Delta County Housing has low interest loans that are used to improve living conditions for those in need.
- 16. Hotchkiss Planning Commission Update Mayor Koontz told the Trustees that Marlin McCracken resigned from the Planning Commission and that the Trustees need to appoint a fellow Trustee to the Planning Commission. The Trustees will appoint someone at the December meeting. Tom Wills reported the Commission is working on the sidewalk ordinance and the downtown improvement plan.
- Leroux Creek Planning Update Carrie Wingfield reported there was not a meeting held.
- 18. Five Minute Public Appearance

Rozellynn Hall, 153 E. Main Street, asked the Trustees for a variance to the Keeping of Livestock in Town regulations so she may keep a dwarf goat as a pet. A Public Hearing will be held on December 13th at the regular Town Trustee meeting. Georgia Hopper asked if the Town could place ads in the paper about dogs being on a lease and not allowed to run at large.

19. Department Reports

Mike asked if there were questions on his written report. There were none. Mike reported there will be additional testing required for sanitation in 2013. The painting of the town shop is complete and the HHS art class will be painting the HHS Bulldog on the front.
