## 1. CALL THE MEETING TO ORDER

#### ROLL CALL

Mayor Wilkening called the meeting to order at 6:30 p.m. Roll call was taken and those present were Mary Hockenbery, Patrick Webb, Esther Koontz and Pat Medina. Absent were John Marta and Sheila Maki.

#### PLEDGE OF ALLEGIANCE

Those present recited the pledge of allegiance.

## 2. CONSENT AGENDA

Mayor Wilkening found an error in item #5, Bruce Stanley's last name was spelled without an 'e'. Esther Koontz moved to approve the minutes with the above noted correction. Mary Hockenbery seconded, motion passed.

## 3. CONSIDERATION OF BILLS

Esther Koontz moved to pay all bills as presented. Pat Medina seconded, motion passed.

## 4. PUBLIC COMMENT

Tom Wills said that he attended the Chamber of Commerce meeting yesterday and the Town Hall won the Christmas Light Decoration contest for the Commercial category. Tom said that the Chamber also expressed concerns about the ban on camping at the Hotchkiss Fair Grounds. He encouraged the Board to come up with a plan to reinstate this program. The third item that the Chamber discussed was the idea of adding a charging station or two (2) for people who drive electric vehicles. There is State funding available to help finance the project.

## 5. OLD BUSINESS

#### BUILDING CODE UPGRADE UPDATE

Mayor Wilkening compiled all of the notes and suggestions that were taken during meetings with John Marta, Patrick Webb and building inspectors John Caven and Bruce Stanley and sent them to Attorney Bo Nerlin. Attorney Nerlin will look them over and put them into an amendment to the Building Code Ordinance for the possible first reading in January.

Some other items of discussion in the new building code are; having a Board of Appeals and the energy code that the Board would like to follow. Some discussion of having the 2015 energy code was had. Attorney Nerlin will survey other Municipalities in our area and how they handle the Energy Code and the Board of Appeals situations. Attorney Nerlin will apprise the Board of the survey results in January.

#### 7. NEW BUSINESS

#### ORDINANCE 2019-02-ADOPTION OF 2020 BUDGET

Mayor Wilkening explained this Ordinance and pointed out the increase in sales tax revenue as compared to last year.

Esther Koontz moved to adopt Ordinance 2019-02, an Ordinance adopting a budget for the Town of Hotchkiss, Colorado for the calendar year 2020. Mary Hockenbery seconded, motion passed.

## ORDINANCE 2019-03-ADOPTION OF 2020 MILL LEVY

Mayor Wilkening explained that the Mill Levy is figured with a formula using 5.5% tax rate and a formula for TABOR. The lowest percentage rate that is figured in these formulas is the one that is chosen.

Mary Hockenbery moved to adopt Ordinance 2019-03, an Ordinance amending established rate of tax to be levied upon all taxable property within the Town of Hotchkiss, Colorado for Municipal purposes for the calendar year 2019. Esther Koontz seconded, motion passed.

# ORDINANCE 2019-04-ADOPTION OF 2019 APPROPRIATIONS AS AN EMERGENCY

Mayor Wilkening explained that this Ordinance must be adopted as an emergency in order for the Town to be able to pay all of the bills coming due in the month of January.

Esther Koontz moved to adopt Ordinance 2019-04, an Ordinance appropriating sums of money to defray expenses and liabilities of the Town of Hotchkiss, Colorado for the 2020 calendar year and declaring an emergency. Pat Medina seconded, motion passed.

# RESOLUTION 2019-04-RESOLUTION TO APPROPRIATE ADDITIONAL SUMS OF MONEY

Deputy Town Clerk Ginger Redden explained to the Board that this resolution was to let the State know why the Town overspent the projected budget for 2019. The two (2) funds overspent in were the Water Fund and the Garbage Fund.

Esther Koontz moved to adopt Resolution 2019-04, a Resolution appropriating sums of money to defray expenses in excess of amounts budgeted for the Town of Hotchkiss, Colorado. Mary Hockenbery seconded, motion passed.

# OPENING AND REWARDING SEALED BIDS FOR VEHICLES FROM PUBLIC WORKS AND THE POLICE DEPARTMENT

Mayor Wilkening told the Board that two (2) bids were received. The vehicles up for bid are a 2006 Ford Explorer from the Police Department and a 2001 Chevy 1500 Pickup from the Public Works Department.

Mayor Wilkening opened the first bid. The bid was in the amount of \$500.00 for the 2006 Ford Explorer submitted by Don Ludwig. This vehicle has 90,000 miles on it and is in good shape. Marshal Miller said that he tried to give it to another Town but they refused.

There were several minutes of discussion about the bid being low. Attorney Nerlin told the Board that they had the right to refuse the bid.

Pat Medina moved to accept the bid in the amount of \$778.52 from Don Ludwig for the 2001 Chevy 1500 Pickup. Esther Koontz seconded, motion passed.

# TOWN ENGINEER REPORT

Engineer Joanne Fagan told the Board that Mike Pitt is hoping to finish up the water tank but it probably will not be until Spring. The parts have to be special ordered and it is not good to have exposed water lines this time of year.

The Public Works crew is working on the road from the Public Works Shop Building, footers have been poured and the cement for the backside of the awning will be done soon. They are hoping to have all of the concrete done by December 23rd or 24th and then will shut down until January. The flooring for the shop will be poured after the steel building is erected in January.

# TOWN MARSHAL'S REPORT

Marshal Miller wished everyone a Merry Christmas. The Police Department has entered into a contract with Julia Thompson. The Police Department will pay for part of the academy for her and then she will work for the Town for the next three (3) to five (5) years. Julia is currently a dispatcher for both Delta and Montrose.

## TOWN PUBLIC WORK'S REPORT

Public Works Director Mike Owens said that the Bruce Stanley, Building Inspector for this project brought up the subject of Radon. The site was tested and did test high.
