Engineer Fagan told the Board that the Water Tank completion has been put on hold until the ground thaws.

It looks like Ford Construction will continue to work all month with no shut down.

### TOWN MARSHAL'S REPORT

Marshal Miller told the Board that he hired Ryan Sparks to be a Deputy for the Town. Julia Thompson has started the Police Academy and the Marshal's Office will be back to full staff in May.

### TOWN PUBLIC WORK'S REPORT

Public Works Director Mike Owens told the Board that the dump truck will be taken to Grand Junction to be worked on.

Mike attended a meeting with CDOT (Colorado Department of Transportation) this morning and the regulations are changing. Policies are being updated and all employees will be registered in the new system. There is no cost unless driving records are checked; each inquiry will cost \$1.25.

### TOWN CLERK'S REPORT

Deputy Town Clerk Ginger Redden reported that an election will be held in April. There are three (3) Trustee seats up for election and all are four (4) year terms. Packets were available starting January 7th with a return date of January 27th. The Trustee seats up for election are John Marta, Patrick Webb and Sheila Maki.
