## MANUFACTURING FEASIBILITY STUDY UPDATE

Mayor Wilkening explained the process leading up to the Feasibility Study and all that this process entailed. Once all of the workshops were done and the survey responses collected, community downtown guiding principles were developed. There are seven (7) principles in all. Mayor Wilkening read the principles to the Board. Mayor Wilkening thanked the volunteers that helped work to get these seven (7) principles identified to help provide a plan of action that can be used by new businesses coming into Town to make the downtown area successful in the future. Mayor Wilkening asked that the Board put a motion in place to adopt these guidelines to be able to move forward with possible grant applications and future projects.

After several minutes of discussion for and against, Patrick Webb moved to approve the adoption of the seven (7) guiding principles to help make the downtown area successful in the future, seconded by Mary Hockenbery. A verbal vote was taken with all Trustees voting, "Yes".

# RESOLUTION 2021-02 BUILDING CODE RATE STRUCTURE FEE DISCUSSION/POSSIBLE ADOPTION

Mayor Wilkening refreshed the Board's memory on this item. In November this item was adopted with a 75% of the National Average charge for a new building built in the Town of Hotchkiss. In December the discussion was reopened with the thought that this number might not be enough and this item was tabled until the January meeting.

# RESOLUTION 2021-02 BUILDING CODE RATE STRUCTURE FEE DISCUSSION/POSSIBLE ADOPTION

A discussion was had amongst the Trustees about the amount to charge and the pros and cons of each amount. Promoting building in the Town of Hotchkiss was also discussed. Patrick Webb moved to approve that the cost of a new building to be built in the Town of Hotchkiss be based on 80% of the National Average cost for a new building, Mary Hockenbery seconded. A verbal vote was taken with three (3) Trustees voting "Yes", Patrick Webb, Mary Hockenbery and Kris Hillman, and two (2) Trustees voting "No", Jim Wingfield and John Marta. Motion passed.

# HOTCHKISS CHAMBER OF COMMERCE UPDATE/ONE DELTA COUNTY UPDATE-KIM SHAY

Kim Shay told the Board that the Chamber was awarded the grant for the car charging stations and they will be placed before CDOT (Colorado Department of Transportation) starts the Little Blue Project on Highway 50. This project will reroute traffic to come through the Town of Hotchkiss. The Chamber has been restructured with Mitch Swanda as president and Kim as vice president. Nathan Sponsellor will be staying on with the Chamber as a paid consultant.

Kim said that One Delta County will be contacting businesses to see how many fulltime employees they have. The rate structure for dues for One Delta County will be figured on population. Kim is working with the new head of One Delta County and will be introducing him to the business owners.

Mayor Wilkening asked the Board for a Volunteer to fill the position on the Planning Commission. Jim Wingfield stated that he would be interested.
