There will be a ribbon cutting ceremony on Wednesday, April 28<sup>th</sup> at 9:30 a.m. Kim asked Larry to represent the Town in cutting the ribbon. Kim is working with CDOT (Colorado Department of Transportation) to get a sign out on the highway for the new stations.

One Delta County is working on bringing new businesses into the County and is also working on their website.

#### 6. PUBLIC COMMENT

Mayor Wilkening explained that this is for comment only and speakers will be limited to five (5) minutes each.

Karen Lacy told the Board that she is concerned for the safety of pedestrians crossing Bridge Street once the Little Blue Project is underway. The Little Blue Project is slated to start on April 19<sup>th</sup> and go for eighteen (18) months. CDOT is repairing and expanding the Little Blue Creek Canyon route on Highway 50 between Montrose and Gunnison. Traffic will be detoured to Highway 92 which means that traffic going through Hotchkiss will increase. There are twentyfour (24) cross walks in Town and Karen would like to see more pedestrian crossing signs. There was several minutes of discussion about pedestrian safety and the need for more education.

#### 7. NEW BUSINESS

#### OUT OF TOWN WATER TAP REQUEST-SHAWNA REED, 1010 HWY 92

Shawna Reed told that Board that they would love to not haul water any more. Public Works Director Mike Owens said that there is plenty of water pressure in that location to support a new tap.

Jim Wingfield moved to approve the above noted Out of Town Water Tap Request at 1010 Highway 92, seconded by Mary Hockenbery. A verbal vote was taken with all Trustees voting "Yes", motion passed.

#### MAYOR'S REPORT

At this time Mayor Wilkening moved the Mayor's report.

The only birthday this month is Don White.

The UTA (University Technical Assistance) Master's Program Project had 304 responses to a survey that they did. There were several different suggestions of items that could be incorporated into the core area if new businesses or even current businesses can incorporate if they so choose. These ideas would make the down town area look better and more inviting. Mary Hockenbery will supply the Clerk's office with a link to put on the Town's website.

West Elk Byway sent a thank you note for their recently received dues from the Town of Hotchkiss.

The Brownfields Program, a program that assesses an area for hazardous waste material, has accepted the Town of Hotchkiss and will hopefully have the assessment done by the end of August for the old Public Works building. There are three other projects in the area that they will coordinate with so that they will all be accomplished about the same time.

Mayor Wilkening attended a meeting with CDOT that discussed the upcoming Little Blue Project. Traffic will be detoured as discussed above in the Public Comment portion. Be prepared if you travel this summer, there is road work going on all over Colorado. CDOT would like to start replacing the ADA (Americans with Disabilities Act) wheel chair ramps along Bridge Street in 2022.
