# NOVEMBER 8, 2022, ELECTION UPDATE

Mayor Wingfield told the Board that the Marijuana Ballot Question passed with a vote of two hundred fifty-two (252) in favor and one hundred eighty-six (186) against. The Town will accept letters of interests from Marijuana companies that would like to be considered for opening a shop in Town. The shops cannot open until at least July of 2023. This will allow the Town time to propose Ordinances and come up with a plan for the implementation of these shops.

# HOTCHKISS AVENUE ENGINEERING WITH THE COUNTY DISCUSSION

Mayor Wingfield told the Board that Delta County Commissioner Wendell Koontz would like the Town to put an amount of \$3,000.00 into the Budget for 2023. This amount will split the cost of engineering fees with the County to investigate expanding Hotchkiss Avenue into the Fair Grounds. After several minutes of discussion, the Board had concerns about this item. Some of these concerns were:

The road not being built to Town specs

A gate that would be locked until the County felt it necessary to unlock it There were not many ways this would benefit the Town

Sven Edstrom moved to table this agenda item until more information is available and the County comes in with a more formal proposal that will start with the Planning Commission, seconded by Pat Medina. A verbal vote was taken with all Trustees voting in favor. Motion passed.

#### 6. PUBLIC COMMENT

Tom Wills, 159 W Main Street, told the Board that he wanted to bring up the Master Plan again. He has concerns that it was not mentioned in the Budget Work Session. DOLA (Department of Local Affairs) offers grants to help with Master Plan updates. Tom would also like the Town to rearrange the agenda to put Public Comment right after Public Hearings. Tom feels that the Public should be able to comment on items before New Business and those action items are done. On a side note, Tom mentioned that the expansion of Hotchkiss Avenue is in the Master Plan.
