1. CALL THE MEETING TO ORDER

Mayor Jim Wingfield called the meeting to order at 6:31 p.m. A verbal roll call was taken. Present were Roger Christian, Randy Thalmann, Custer McLeod, Jim Jorgensen and Pat Medina arriving at 6:33 p.m.

Absent was Sven Edstrom.

Those present recited the Pledge of Allegiance.

2. CONSENT AGENDA

MINUTES FOR SEPTEMBER 12, 2024

Roger Christian moved to approve the minutes as presented, Custer McLeod seconded. A verbal vote was taken with all Trustees voting in favor. Motion passed.

3. CONSIDERATION OF BILLS

Town Clerk Ginger Redden read off the additional bills.

Custer McLeod moved to pay the bills, Roger Christian seconded. A verbal vote was taken with all Trustees voting in favor. Motion passed.

4. NORTH FORK MINERS STUDENT COUNCIL-UPDATE ON HIGH SCHOOL HAPPENINGS

Mayor Wingfield said that he would reach out to the High School to see if representatives would be able to attend the meetings again. Lindsey Todd from the crowd said that there is a new person in charge of the council, and she will reach out to them for the Mayor.

5. PUBLIC COMMENT

Ruth Pettigrew, 344 N 3rd Street, asked the Board, with the draft of Chapter 17 being presented, if there was identification established between domestic and feral cats, if a grandfather clause was in effect for those with possibly more than four cats.

Liz Heidrick, Crawford Colorado, mentioned that CAWS is a helpful resource for a TNR program. They Spay/Neuter, vaccinate and place cats that have a friendly personality in the adoption system.

VARIANCE REQUEST FOR THE KEEPING OF LIVESTOCK-336 MINERS WAY-LINDSEY TODD

Mayor Wingfield told the Board that the Planning Commission recommended approval of twelve (12) horses for this request. He stated that he was in favor of approving this request, Jim Jorgensen agreed. Mayor Wingfield said that this property was annexed into Town so that the High School could be built in its current location. Lindsey Todd told the Board that the school is very helpful with being able to offer such resources for school agricultural projects. Liz Heidrick said that she is very appreciative of the Planning Commission and the Board of Trustees for being able to have property in a community that supports livestock.

There were no public comments for this hearing.

Custer McLeod made a motion to approve the Variance Request following the Planning Commission recommendation on the property of 336 Miners Way, Pat Medina seconded. A verbal vote was taken with all Trustees voting in favor. Motion passed.

8. OLD BUSINESS

RESOLUTION 2024-02 CLERK'S OFFICE HOUR AND DAY CHANGE

Pat Medina said that she has gotten many calls about this due to the Merchant Herald. She said that she would like to see this as a six (6) month trial, instead of a complete change over. Roger Christian stated that he too thought that it would be for a trial period. Attorney Bo Nerlin clarified that it could be approved with the contingency for the six (6) month review. Roger Christian made a motion to approve Resolution 2024-02 with the contingency that it come back for review after six (6) months, Pat Medina seconded. A verbal vote was taken with all Trustees voting in favor. Motion passed.

ORDINANCE 2024-01 CHAPTER 17 POSSIBLE FIRST READING

Jim Jorgensen and Pat Medina both stated that there has been a lot of public comment made on this Chapter 17 revision and that it would be great to be done with it.

Pat Medina made a motion to approve Ordinance 2024-01 as a first reading, Custer McLeod seconded. A verbal vote was taken with all Trustees voting in favor. Motion passed.

Mayor Wingfield said that there has been a couple meetings so far with budget as it has been hard but it is getting done.

Mayor Wingfield said that he had a meeting with Wendell Koontz and he is looking for someone to fill a vacant position on the Gunnison Basin Roundtable.

Bo Nerlin gave a presentation addressing affordable housing and updated rules on evictions, Municipal laws, and Natural Medicine.

DONATION REQUESTS

NORTH FORK COMMUNITY DINNERS-LARRY JAKUBIAK/PAT MEDINA

Pat Medina represented Larry Jakubiak for the North Fork Community Dinners. She said that Larry is asking five hundred (\$500) dollars for the Thanksgiving and Christmas dinners. There has been a large turnout for these events.

Roger Christian made a motion to approve the Donation Request for \$500.00 to the North Fork Community Dinners, Custer McLeod seconded. A verbal vote was taken with all Trustees voting in favor. Motion passed.

NORTH FORK SENIOR CONNECTIONS-BONNIE EISENBERG

Bonnie Eisenberg commended Hotchkiss for doing the meals every week at the Senior Center. Their organization is seeking support in a donation to assist Seniors within the North Fork Community that wish to live independently within their own homes. Handy Helpers is another benefits service that they provide to help Seniors within their homes with household handyman jobs. They also provide assistance with seasonal tasks as well. They are looking to assist at least a dozen Seniors within Hotchkiss. They are looking to recruit a Board Member that resides in Hotchkiss. Mayor Wingfield said that he thinks this is a great idea.

Jim Jorgensen made a motion to approve the North Fork Senior Connection Donation Request for five hundred (\$500) dollars, Pat Medina seconded. A verbal vote was taken with all Trustees voting in favor. Motion passed.

STREET CLOSURE REQUEST-HOTCHKISS ELKS LODGE

Mayor Wingfield said that the Hotchkiss Elks Lodge is requesting to close Second Street between Bridge Street and Main Street. Teresa Burns told the Board that they were busier last year than they thought that they would be. This led to a lot of kids being confused with the Hotchkiss Fire Trucks being in the middle of the parking lot. She is wanting to close the street off so that they can have a cattle pod haunted house and to provide more room for vehicles for the Trunk R' Treat. They would like to close the street from 4:00 p.m. to 6:30 p.m.

Custer McLeod made a motion to approve the street closure for Hotchkiss Elks Lodge, Jim Jorgensen seconded. A verbal vote was taken with all Trustees voting in favor. Motion passed.

2025 BUDGET-FIRST DRAFT-POSSIBLE WORK SESSION DATE

The Trustees discussed setting a date and scheduled the Budget Work Session for Wednesday, October 16, 2024, at 6:30 p.m.

ORDINANCE 2024-03 SANITATION TO WATER LOAN PAYMENT FORGIVENESS

Bo Nerlin explained that a loan was taken out in 2003 for the Sanitation Plant. This loan was then refinanced in 2013. In 2015 the Town paid the loan back by taking an interfund loan from the Water Fund to pay this loan off early. Due to the 2023 Auditor Report, the Water Fund is healthier than the Sanitation Fund. Per the Auditor, he states that the loan at this point could be forgiven. It was researched to see if forgiving this loan would jeopardize the funds or if it would create issues with finding funding past 2024. Attorney Bo Nerlin said that he got a positive recommendation to forgive this loan with it not affecting future financing options. Attorney Nerlin said that this item could be approved in this meeting as a first reading and come back to the Board in November as a Public Hearing.

Pat Medina made a motion to approve Ordinance 2024-03 as a first reading, Custer McLeod seconded. A verbal vote was taken with all Trustees voting in favor. Motion passed.

11. ADJOURNMENT

The meeting was adjourned at 7:46 p.m.
